Lake, Kolkata - 700045 hereinafter referred to as the "**TRUSTEES**" (which expression shall unless repugnant to the context or meaning thereof be deemed to include the survivors or survivor of them and the trustees or trustee for the time being of those present and their heirs, executors and administrators of the last surviving trustee, or their assignees of the OTHER PART;

WHEREAS each of the parties hereto of the "Other Part" has individually and jointly agreed to act as Trustees of the Trust, proposed by the party of the First Part.

AND WHEREAS the party hereto of the First Part is possessed of the sum of Rs. 10,000/- (Rupees Ten Thousand only) hereinafter referred to as his absolute property and he is desirous of creating a Charitable/Educational Trust for the benefit of the humanity at large.

AND WHEREAS the Author of the Trust desires to endowing the said funds upon trust for public, educational and cultural purposes, as hereinafter expressed and contained in this presents and in pursuance of such desire have already transferred, paid and handed over the said corpus to the " Party of the Other Part " (trustees) mentioned above.

AND WHEREAS the Trustees shall stand possessed of the said amount of corpus endowed by the Author of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.

AND WHEREAS it is the desire of the Author of the Trust that the Corpus of the Trust may be further augmented from time to time by flow of funds and

other assets including moveable and immovable and any other kind by way of gifts, or donations, acquisitions, allotments, grant exchange or otherwise etc.,

AND WHEREAS nothing contained in this deed shall be deemed to authorize the trustees to do any act which may in any way be construed statutory modifications thereof and all activities of the trust shall be carried out with a view to benefit the public at large, in the territory of India without any profit motive and in accordance with the provisions of the Income-tax Act, 1961 or any statutory modification thereof.

AND WHEREAS the trust shall be an irrevocable public educational, cultural trust for the benefit of all persons belonging to all strata of society, irrespective of Community, Caste, Creed or Religion. The income or benefit of the Trust shall never be applied or utilized by the Trustees.

AND WHEREAS the trust is hereby expressly declared to be a **public charitable trust** and all the provisions of this deed are to be constituted accordingly.

**NOW THIS INDENTURE WITNESSTH AS FOLLOWS:**

**1. NAME :**

The name of the Trust shall be “ **RUDRAKSH EDUCATIONAL TRUST** ” hereinafter referred to as the Trust.

**2. PLACE :**

The principal office of the Trust shall be situated at Chhoto Canthalia, P.O. – Sewli Telinipara, P.S. – Titagarh, Kolkata – 700 121, or such other place as the Trustees may from time to time decide. The Trust may also carry on its work at any other place or places, as decided by the Trustees.

**3. OBJECTS :**

The objects of the Trust shall be for public & charitable purposes and its income shall be applied in India for public & charitable purposes and without prejudice to the generality of the aforesaid, the following shall be objects of the

Trust and shall not be based on consideration of any caste, creed, community or nationality :-

- a) To establish, run, maintain or assist Institutions for school education, higher education, technical education, management education and other professional education with primary aim to impart high quality education and ensuring continuous improvement of human capital in the country.
- b) To establish, run, maintain the Information Technology Training Institutes and centers for coaching, career guidance, counseling & vocational/ Industrial training for the youth.
- c) To grant financial aid, scholarships, textbooks, notebooks, uniforms/ cloth, meals to the poor, deserving and needy students enrolled for elementary, secondary, higher education or professional education.
- d) To establish run, maintain or assist medical or Para- medical education institutes, hospitals, nursing homes or clinics and to provide financial assistance to needy and indigent persons of the society for meeting the cost of medical treatment.
- e) To grant financial or other assistance in kind, meals for the poor & indigent and to the persons who suffer due to natural calamities.
- f) To establish run, maintain Libraries, Reading rooms, Crèche, Family Welfare Centres, and Community Halls for public use to conduct training classes, seminars, discourses, workshops and other public functions for benefit of the community in general.
- g) To establish run, maintain cultural, social training institutions /centres; teachers' training institutions and research & training centres for the furtherance of cause of education/learning in the society.

- h) To acquire and maintain the movable and immovable properties by outright purchase or on lease or on Build-Operate-Lease (BOL) basis for achieving the said objects.
- i) To grant, pay or give scholarship, stipends, prizes, rewards, educational loans, allowances and other financial assistance or help in cash or kind to the deserving and the needy students with a view to help them pursue their studies in schools, colleges, educational institutions, technical institutions, art schools, institutions teaching commercial and other arts including teaching of cultural arts or other training, research or educational works in India or abroad.
- j) To receive donation from organization, trusts, institutions, public and/or individuals in cash and/or in kind and to receive subscriptions or publication of souvenirs for raising fund for the development, furtherance and/or spreading education, morality and/or humanity among the people and/or for the purpose of relief and/or any other public charitable objects including rehabilitation and/or helping persons affected by War, Tremors, fires, Accidents, Floods, Droughts, Volcanoes, Landslides, Excessive-rain, Riots, Pestle attack, Famines and due to any natural calamities and/or in times of other disasters.

#### **4. PRESIDENT:**

There shall be a president for the administration of this trust, nominated by the board of Trustees, who shall be one amongst trustees.

#### **5. MANAGING TRUSTEE :**

The day-to-day administration of the Trust shall be looked after by the Managing Trustee, under the guidance, control and supervision of Board of Trustees. The Board of Trustees shall nominate one amongst the trustees, who shall hold office for such period, as may be decided by the Board of Trustees. The Managing Trustee shall perform all functions, discharge such duties as or specifically entrusted to him/her in writing by the Board of Trustees.

**6. NUMBER OF TRUSTEES/ VACANCIES:**

The Trustees will be collectively known as board of Trustees. The Trust and all its Properties will remain vested in the Board of Trustees (hereinafter referred to as the 'Board') which shall consist of not less than Two Trustees and not more than Twenty Trustees. The present Trustees named in this Deed of Trust shall be Trustees for their lifetime but anyone of them may resign by giving notice in writing and shall cease to be a Trustee on such resignation. Upon the death of any of the Trustees or in the event of any one of them shall desire to retire or to be discharged from or refuse to act or become unfit to continue as trustee by reason of any personal disqualification or become incapable to act as trustee as aforesaid then in every such case, the surviving and continuing trustees for the time being shall appoint and co-opt. the nominee (who shall be his full blood relation) of such outgoing trustee or one of the legal heir (decided either by mutually among legal heirs or by court order) of so dying, desiring to be discharged or refusing or becoming unfit or personally incapable to act as aforesaid.

**7. MEETING AND PROCEEDINGS OF THE TRUSTEES:**

The Trustees shall ordinarily meet once in three months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust. In case of any difference between the trustees, the opinion of the majority shall prevail. The quorum of the Board Meeting shall be 1/3<sup>rd</sup> of the total number of Trustees at that time.

**8. TERMINATION / APPOINTMENT OF THE TRUSTEES:**

- (a) Trustee shall cease to hold office:
  - i) if he/she dies,
  - ii) if he/she resigns,
  - iii) if he/she is adjudged insolvent or found guilty of an offence involving moral turpitude.

- iv) if he/she is found to have acted against the interest of the Trust. if it is unanimously decided by the Trustees that his continuation in the Office is against the interest of the Trust.
- (b) Any of the trustees may retire on giving one month's notice in writing to the board of trustees.
- (c) If any trustee dies or retires or becomes incapable or unfit to act, the continuing or surviving trustee or trustees shall appoint a successor in the place of such trustee who shall be a relative with blood connection.

#### **9. POWER OF TRUSTEES**

That the trustees shall have the following powers:

- (a) To manage all the assets and/or properties of the trust including the conduct of all affairs of the Trust;
- (b) To appoint employees and to settle the terms of their service, remuneration and termination;
- (c) To look into the management of the trust;
- (d) To invest the funds of the trust, in bank, shares or securities or bonds or other movable and immovable properties or other investments as may from time to time seem expedient at the unfettered discretion of the Trustees subject to the Provisions of the Indian Trusts Act and the Income Tax Act, 1961;
- (e) To sell, alter, vary, transpose or otherwise dispose or alienate the trust properties or any investment representing the same for consideration and to reinvest the same;
- (f) To pledge or mortgage the trust properties for raising loans;
- (g) To open the bank accounts in the name and on behalf of the trust and to operate the same;

- (h) To pay all charges, impositions and other outgoings payable in respect of the trust properties and also to pay all cost of the incidental to the administration and management of the trust properties;
- (i) To file suit on behalf of the trust and to refer to arbitration all actions proceedings and disputes touching the trust properties and to compromise and compound the suits filed;
- (j) To accept any gift, donation or contribution in cash or in kind from anyone for the objects of the trust;
- (k) To seek legal opinion of lawyers and/or Chartered Accountants as and when required; or to nominate representatives for any of the aforesaid purposes.
- (l) No trustee shall be responsible or liable for any loss or any act of omission or commission by the constituted attorney or agent or employees or other trustees unless occasioned by his willful neglect or default.

#### **10. FUNDS:**

The Trustees may accept donations, grants, subscriptions, aid or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trust. While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the granter.

#### **11. INVESTMENTS:**

- a. All money, which shall not be immediately required for current needs shall be invested by the Trustees in eligible securities and investments as notified by government of India, or in scheduled banks. Such investments shall be in the name of Trust.

- b. That the trustees shall invest the trust fund, conduct business with the trust fund and/or enter into partnership on behalf of the trust, as they may deem fit as per objects of the trust.
- c. That the trustees shall manage the trust fund and investments thereof as a prudent person would do the same. They shall recover all outstanding dues and meet all recurring and other expenses incurred for the upkeep or management thereof.
- d. That the trustees shall receive and hold the income of the trust on behalf of the trust.

**12. BANK ACCOUNT:**

- a. The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of Rudraksh Educational Trust. The Managing Trustee and any other of the Trustees shall jointly operate such accounts as shall be decided by the Board time to time.
- b. The trust may also open Bank Account/s in the name of institution / organization founded by the Trust. These Bank Accounts shall be operated by such persons, as authorized by the board of trustees from time to time.
- c. All income, subscription and pecuniary donations for the general purposes of the Trust and the income, investments and all other money from time to time forming part of the general revenue of the Trust shall on the same being received be paid into a bank account with any scheduled bank for the purpose of the Trust.

**13. APPLICATION OF THE PROPERTIES OF THE TRUST:**

The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any temporary remuneration or allowance or giving of residential accommodation or any

perquisites to any trustee in connection with the work carried out by him/her for the purpose of the Trust.

**14. DEFECTS OF PROCEDURE IMMATERIAL:**

No act of Trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof.

**15. AMENDMENTS:**

No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 and 13 and 80G of the Income Tax Act, 1961 as amended from time to time.

**16. ACCOUNTS AND AUDIT:**

The Trustees shall keep proper books of account of all the assets, liabilities and maintain a true and correct record of the receipts, payments incomes and expenses and transactions of the Trust and shall prepare an Income and Expenditure Account and Balance Sheet for every year as on the last day of March. The accounts shall be audited by a Chartered Accountant or a firm of Chartered Accountants, who shall be appointed for that purpose by the Trustees and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.

**17. IRREVOCABLE:**

This Trust is irrevocable.

**18. DISSOLUTION/ AMALGAMATION/ WINDING UP:**

In the event of dissolution or amalgamation or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees but the same shall be transferred to some other similar Trust / Organisation, whose objects are similar to those of this Trust with the prior permission of the Charity Commissioner / Court / any other law as may be applicable for the time being.


