AND WHEREAS the trustees hereto have consented to carry out the trust herein created.

AND WHEREAS with the view to and for the purpose of constituting the trust permanently for the purpose of accomplishment of the objective of the trust mentioned hereafter under the "AIMS & OBJECTS" clause of this DEED of The Declaration of Trust, it is considered desirable that for the purpose of certainty of this trust the declaration of The Trust should be made in the manner set out hereunder:

**NOW THIS INDENTURE WITNESSETH AS FOLLOWS :-**

- 1.a) The Trust is constituted as a Private Discretionary Trust.
- b) The name of the Trust Shall be **UNIQUE EDUCARE TRUST**.
- c) The Registered Office of the Trust for the present shall be located at Vill.- Khidirpur, P.O- Chhabghati, P.S.- Suti, Dist- Murshidabad-742201.
- d) The Corporate office of the Trust shall be located/ situated at 25, Gardener Lane, Ground Floor, Kolkata-700014.

The Trustees shall have the right to shift the office to any other place or open local offices at places deemed necessary.

**2. Interpretation:**

- a) Trust means the Trust created by this Deed, viz. **UNIQUE EDUCARE TRUST.**
- b) The Trust hereby created is a Private discretionary Trust.
- c) The Board shall mean the Board of Trustees created by this Deed.
- d) Trust Property shall include every kind of property movable or immovable owned by the Trust and mentioned in the Books of Accounts and other documents in the possession custody and control or that ought to be in possession, custody and control or possession of the Trust.

**3. Aims and Objects:**

- a) To establish, build, set up, construct, take over, conduct, run, aid and hold, maintain or otherwise support Schools, Colleges, Educational Institutions, Educational Board, Technical College, Nursing College, Law College, Dental College, Technical Institute,

Management Institute, Open Universities or other Institutions for imparting educations, training and diffusion of knowledge in different branches of medical science, science and technology, management, humanities and social sciences in India and/or abroad;

- b) To establish, build, run, set up, construct, acquire, purchase, take on lease in India and/or abroad any branded school specially run in India by Zee Group "Mount Litera Zee School" or any such other school as the trustee may decide from time to time.
- c) To establish, build, setup, construct, acquire, purchase, take on lease, take over, conduct, run, maintain, aid, hold, support, promote complete all kind of competitive examination including training / coaching centre of JEE in west Bengal as well as all India level, WBCS, IAS, IPS, IRS, IFS and all kind of other competitive coaching and training centre for the respective examination.
- d) To establish, build, setup, construct, acquire, purchase, take on lease, take over, conduct, run, maintain, aid, hold, support, promote complete all kind of Medical College & Hospital, Medical

College, Hospital, Nursing Home, Nursing Training Centre, Nursing Training Institute, Diagnostic Centre, Pathological Laboratories, Medicine Stores, Medical supplies centre, Medical facilitation centre, Hostel building for medical professionals and students and nurses, of and for all forms of allopath homoeopath, ayurved, unani, and other forms of medical facilities and all other allied medical education, medical treatment, medical facilities and centre in India or outside India.

- e) To establish, set up, takeover, conduct, run, aid and hold, maintain or manage in India or outside India Training and Research Centers for conducting Medical and other Research, Research oriented work and imparting practical training in different branches of Medicine, Science & Technology, Administration & Management, Humanities, Social Sciences, Environment science and pollution control and to help and assist financially or otherwise, persons or associations or organizations engaged in the research and advancement of the aforesaid subjects.
- f) To award Diplomas, Certificates and /or Degrees for the different courses conducted and organized by the Trust or different units of

the Trust and for this purpose to obtain affiliation or enter into any tie-up arrangement with a University and other educational institutions in India and abroad and to comply with all the legal formalities/ procedures pertaining thereto.

- g) To develop facilities for the internship in Technology and Management education.
- h) To design, Demonstrate and present different types of researches, lectures, practical training and consultancies on various aspects of Technology, Management, M.I.S., Medicines, Humanities and Social Sciences, Arts etc. for the benefits of students, teachers, industries , business houses, social groups and organizations and the public in general.
- i) To establish and maintain Adult and Child Educational Institution and self- Help & employment generation Centers especially in the rural areas and in slums for eradicating illiteracy and employment respectively.
- j) To construct school buildings primarily for the children belonging to the economically weaker sections of the society in general and

backward sections among religious and linguistic minorities in particular.

- k) To establish and run old age homes for the elderly people and to establish and run crèches and schools for the children of workers employed in factories and in construction sites.
- l) To establish and run educational institution, hospitals and medical facilities in rural areas exclusively for women and children up to twelve years age.
- m) To take over, establish, acquire start, run, maintain, or manage in India Hostels, Boarding houses, Libraries, Study Centre, Nursing /Midwifery Training Centers, Nursing College, Dental College, D.Ed College, B.Ed. Colleges. Medical College, Humanities Education, Handicraft training and production Centers for the promotion of Education and Vocational Skill among the boys and girls in general and the backward sections amongst the religious and linguistic minorities in particular .

- n) To take over, establish, acquire, start, run, maintain or manage in India Agriculture and Horticulture Training Centers, Firms, Fishery and Poultry Training Centers, Fruit Processing Training Centers for the economic and social upliftment of the people in general and rural youths in particular.
- o) To conduct and organize Seminars Symposiums and Public meetings to create and promote cultural & moral values, communal harmony & peace and to eradicate & abolish communal hatred & ill-feeling among the people.
- p) To establish, furnish and help in establishing and furnishing Publishing House for the promotion of General Knowledge and Culture and also Publishing of Books, Magazines, News Paper and Journals.
- q) To take over, establish, acquire, start, run, maintain or manage in India Teachers Training Institutes, Polytechnics and Industrial Training Institute for boys and girls in general and backward sections amongst religious and linguistic minorities in particular.

- r) To award Scholarship for the deserving students or Technical, Medical, Profession and Cultural Studies and also to grant Interest-free Loans for Self-Employment to the boys and girls in general and backward sections amongst religious and linguistic minorities in particular.
- s) To take over, establish, acquire, start, run, maintain or manage in India Career Counseling Bureau, Centre for Human Rights Awareness and Distress Management Centers.
- t) To organize Relief Camps, Relief Work in the event of Natural Calamities, major Accidents, Riots and Social upheavals in any part of India.
- u) To declare and give gratuities, pensions, bonus, and other amenities and allowances to persons who are or were in the employment of the Trust and their families or dependents or other persons as may be decided by the Trustees and /or authorized under law or Income tax Act 1961 or statutory modification thereof against the services rendered by the said persons for the purpose of fulfillment of the objects of the Trust.

- v) To associate, cooperate, affiliate and collaborate with any other organizations having similar aims and objects.
- w) To do all such things as the Trustees will deem fit, necessary, incidental and conducive to the dictates for teachings of the Sustainer for the attainment of all or any of the objects of the trust.

**4. Beneficiaries of the Trust:**

- a) The Trust shall operate for the benefits of the Institutions to be created, acquired, maintained or managed by this Trust in particular, for the benefits of the trustees and their family members and for the benefits of the general people at large irrespective of religion, caste or creed.
- b) Special attention shall be given to and for the economically and educationally backward classes including minority communities where the charitable centers and functional units will be established by the Trust.

- c) The income or assets of the Trust shall and may be applied or transferred at any time in whole or in part for the benefits of the beneficiaries or trustees and their family members or for any purpose other than for the benefit of the Trust so long as the Trust is in existence.
- d) The surplus of un-applied portion of the income or the Trust fund, if any arising in any one or more year(s) shall be accumulated and/or invested in accordance with all the relevant provisions of the Income Tax Act 1961 as may be in force from time to time.

**5. Raising of Fund and Expenditure:**

- a) For achieving any or all the objects of the Trust, the Trustees can raise funds through Donations, Grants and Voluntary Contributions and can also receive Loans from Bank, Financial Institution, Individuals, Firms, Institutions, Associations or Organizations and shall have the rights to invest and deal with the money and funds belonging to the Trust in such manner as may from time to time be determined by the Board of Trustees subject to law of the land, and to take on lease or purchase or

accept by way of gift any land, building or any other moveable or immoveable property, and remunerate any person or firm or services rendered to Trust in any capacity and pay out of the funds of the Trust all costs, charges, expenses incidental and conducive to the accomplishment of all or any of the object of the Trust and shall also receive Loans, Grants and Donations from Foreign Governments, Institutions or Agencies and Individuals in accordance with the prevailing law of the land, and also to receive loans from Banks, or other Financial Institutions for the benefit of the Trust.

- b) The Income and Properties of the Trust whatsoever and howsoever derive or obtained shall be applied solely for the promotion of the aims and objects of the Trust and no portion thereof shall be paid to or divided amongst the members of the Trust by way of profits.
- c) The Trustees shall not be entitled to receive any remuneration but they may reimburse themselves of all expenses actually incurred or to be incurred by them in connection with Trust or their duties relating thereto.

- d) It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.

**6. Trustees:**

- i) The following members shall be the First Trustees of the Trust and they shall be the permanent trustee unless otherwise incapacitated or resigns:

ii) The Trustee appointed under these presents will be the trustees for as long as they wish and will exercise powers in the name of the Trust thus created by these presents unless any of them resign or otherwise vacate their office or become incapable of acting as Trustee. The terms of appointment, reappointment and retirement of additional Trustees shall be governed by the following provisions:

a) There shall be Board of Trustees comprising of not less than five and not more than nine members.

- b) Any vacancy in the Board of Trustees shall be filled up by nomination by the remaining Trustees from within the family of the Trustees by decents.
- c) The Board of Trustees will be at liberty to appoint additional Trustee or Trustees within the number mentioned above for such period and on such terms as the retirement and reappointment as the Board of Trustees for the time being considered proper.
- d) Any Trustees may resign by giving 30 days notice in writing to the Board of Trustees.

**7. Vacancies:**

The Vacancies shall arise among the Trustees in the following event :

- a. When a Trustee Dies,
- b. When a Trustee resigns as a Trustee,
- c. When a Trustee is absent from three consecutive meetings of the Board or one year whichever is longer unless the Board records condoning such absence in minutes of the meeting of the Board of Trustees,
- d. When a Trustee become insolvent,

- e. When a Trustee is convicted to any criminal offence involving moral turpitude,
- f. When a Trustee acts or does anything detrimental to the interest of the Trust,
- g. On medical evidence when a Trustee is declared physically or mentally unfit by a resolution of the Board at a meeting convened for the purpose.

8. **Vacancy Fill-up:**

In the event of any vacancy arising among the Trustees, new Trustees shall be nominated and appointed from the general members of the Trust with the consent and approval of the remaining trustees and such persons appointed as Trustees shall be of sound mind and health and shall be above 21 years of age and shall subscribe to the aims and objects of the Trust. The Board of Trustees shall fill-up the vacancies arising in the Board of Trustees by a two-third majority of the existing members attending the meeting convened for the purpose but not in no case it shall be less than three Trustees physically present.

**9. Rights and Responsibilities of the Trustees:**

- a) The Trustees shall be accountable only for such assets and funds that shall actually come to their hands. A Trustee shall not be answerable or accountable for any neglect, default, acts of omission or commission of the other Trustees, or any Banker or other person with whom the Trust properties or any securities might have been deposited or kept in the ordinary course of business.
- b) A Trustee is liable to indemnify the loss caused to the Trust property or sustained by the beneficiary due to a breach of Trust committed by the him except where the beneficiary has by fraud induced the Trustee to commit the breach or share the beneficiary is an adult and of sound mind and had concurred the breach of has acquiesced therein with full knowledge of all facts.
- c) A Trustee cannot claim set off his liability for any loss caused by a breach of trust in respect of one portion of the Trust Property against a gain that has accrued to another portion of the Trust Property through another and distinct breach of trust.

- d) A "Breach of Trust" is breach of any duty imposed on a Trustee as such by any law for the time being in force.
- e) The Trustee shall have the right to determine in case of doubt whether any money and property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoings ought to be paid or borne and every such determination shall be binding and inclusive provided that nothing contained shall be deemed to authorize the Trustee to spend from the income corpus of the Trust for any purpose not authorized by these presents.
- f) A Trustee is not liable for the acts defaults of his predecessor. The Trustees shall not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust of their duties relating thereto.

**10. Board/Number of Trustees:**

The properties and funds of the Trust shall vest in the Board of Trustees constituted by persons executing the deed of Trust. The number of members of the Board of Trustees shall not be less than 5 (five) and shall not exceed 9 (nine) and if there arise vacancies the same shall be filled by co-option by the Board of Trustees from among the General Members or family members.

**11. Terms of Office of Board of Trustees:**

The Board of Trustees shall elect the office bearers from among themselves within a month from the formation of the Trust. They shall remain in office for 5 years. The Board will elect office bearers for the next month among themselves in a meeting convened for the purpose within one month from the expiry of the existing term.

**12. Office Bearers:**

The office bearers of the Board of Trustees shall be as follows:

The Board of Trustees is authorized to create any other post of office bearers with such powers and functions, as the Board may deem fit and proper for the management of the Trust. The Trustees shall appoint the office bearers from amongst themselves in the meeting convened for this purpose.

**13. Powers and Functions of the Board of Trustees:**

The General Management and control of the Trust for the purpose of managing the Trust affairs and properties shall vest in the Trustees appointed hereafter under the provisions of these presents. For furtherance of the objects of the Trust, the Trustees shall have the following powers:

- a) To take part in day to day activities of the Trust.
- b) To accept and receive donations, gifts, endowments, contributions, grants and subscriptions in cash or in kind including any property from any persons, body of persons,

company or Trust on such terms and conditions as the Trustees may think fit and proper, provided however that the conditions if any, attach thereto are not inconsistent with the objective of the Trust.

- c) To accept purchase, receive, take on lease, rent or hire or otherwise acquire or transfer any moveable or immovable property rights and privileges on such term and conditions not inconsistent with the forgoing objectives of the Trust or for the benefits of the Trust.
- d) To create or cause to be created building or buildings equipments and machinery and all other things necessary for the use, benefits and the attainment of the objects of the Trust.
- e) To sell, alter, develop, vary, transpose, dispose of, otherwise deal with any property, moveable or immovable, comprising the Trust property or any investment representing the same and to reinvest the same for the benefits of the Trust in any manner as the Trustees may think fit and approved by a majority of two-third of the Trustees in the meeting of the Board of Trustees convened for the purpose.

- f) To manage, administer and control all properties and assets of the Trust directly or indirectly and all Institutions under or connected with the Trust.
- g) To sponsor, franchise, establish, maintain and run educational and professional institutions and hospitals for achieving the objective of the Trust and manage the same by appointing or nominating members to the governing Body Council/Managing Committee of each such institutions thus established and maintained.
- h) To draw schemes or schemes, make such arrangements and frame such bye-laws and rules as the Trustees shall in either absolute discretion think fit proper for the administration of the Trust hereby constituted and the management of the Trust Property hereby convened or any part thereof or any other property for the time being subject to the provisions of this deed or any part thereof and may at any time amend, alter or repeal any of the said arrangements, scheme, bye-laws or rules as they shall think fit for the development of the Trust Property and for the furtherance of the objectives.

- i) To make, vary, alter, amend, rescind, delete or modify schemes, bye-laws rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof, and of running any institution, working division, enterprise or undertaking in furtherance of objects of the Trust and otherwise for giving effect to objects of the Trust.
- j) To seek collaboration, cooperation, affiliation accreditations and articulations with any other organizations, institutions, academics and universities at the national and international level for the furtherance of the object of the Trust.
- k) To appoint officers or other employees to look after and manage the properties constituting the Trust Fund/Trust property and allot such persons, such duties as the Trustees may think fit and proper and to dismiss such officers or employees if they are found unsuitable or untrustworthy at a later date.
- l) To appoint Governing Body/Council and or Managing Committee and or Other Bodies or Committees and delegate to such Council

or Committee or Bodies such powers and authorities for the purpose of conveying out the objects of the Trust.

- m) To appoint and make provisions for appoint of any person including all or any of the Trustees as members of a Body/Committee or as Administrator or otherwise for the purpose of administration of the Trust in such manner and subject to such rules and regulations as the Trustees may prescribe and also to appoint or provide for such appointment of separate Trustees to hold any property or any fund or investment, subject to such rules and regulations as the Trustees may from time to time think fit.
- n) To appoint Constituted Attorneys or Agents and to delegate to Attorneys or Agents all or any of the powers vested in them under these presents from time to time and to remove such Attorneys or Agents and to appoint other or others in his or their place.
- o) To do all such lawful acts either alone or with other Agencies, Organizations or persons as the Trustees may consider necessary,

incidental or conducive to the attainment of the objectives of this Trust or any of the things which are connected with the Administration of the Trust or of the Institutions run or managed by the Trust and which are deemed by the Trustees to be in the best of interest of the Trust and desirable.

- p) To apply the whole or any part of the Income of the Trust, or the Trust Fund or accumulations thereto or whole or part of the Corpus of the Trust Fund or Trust property, for any one or more of the objects of the Trust, as the Trustees may, in their discretion, deem fit from time to time.
- q) To invest or keep invested the Trust fund and income thereof either in the purchase or mortgage of immovable property or shares, stock or debentures or mutual funds or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments from time to time as the Trustees may in their discretion think fit and proper.

- r) To convert and deal with the Trust Fund or Trust Property and/or vary in the investments for the time being.
- s) To borrow money from Bank or financial institutions for the purpose of the Trust and management of its properties against mortgage or the Trust Property and/or its sponsored Institutions and/or personal guarantee of the Trustees either individually or jointly or otherwise or raise or secure payments or moneys and also to lend money to sponsored Institutions and public charitable societies or Trusts having similar objectives fully consistent with the following objectives of the Trust on such terms and conditions as the Trustees may think fit and proper either with or without security.
- t) To let out or demise any immovable property comprised in the Trust Property for such period and at such rent or such terms and conditions as the Trustees in their absolute discretion may think fit and proper.
- u) To open account in the name of the Trust, Trustees and/or Institutions/Units of the Trust with a Bank or Banks and to give

instructions to the Banks for the operation of such accounts by the Trustees or by one or more agents appointed by the Trustees.

- v) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund or Trust Property.
- w) To get this Trust registered under provisions of the Income Tax Act,1961 and apply the accumulated income for one or more of the objects of the Trust as per provisions of the Income Tax Act,1961 and/or any other law for the time being in force.
- x) To give aid by way of donations out the Income for the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or trusts in India which may have been established or which may hereafter be established for the charitable purposes mentioned in these presents or any of them to enable such institutions, societies, organizations or trusts or start maintain, or carry out such charitable objects.
- y) To apply to the Government , public bodies, urban, local, municipal, district and other bodies, corporation, companies or

persons for and to accept grant of money and of aid, donations, gifts, subscriptions and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Government Departments , public and other bodies , corporation, companies or persons , scheme and other work and matters within the objects of the Trust and to confirm to any proper condition upon which such grants and other payments may be made.

- z) To join, co-operate or amalgamate this Trust with other or others in India having kindred or allied objects, upon such terms and conditions as the Trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust. To transfer and handover the Trust or Institutions under control of this Trust to any other Society, Corporation, Institution, Trust or Organization in India on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institution, Trust or Organization in India with the powers , provisions, agreements and declarations, appearing and

contained in these presents subject to such modifications as may necessary consequent to such transfer. The Trustees for the time being of these presents shall become discharged from the Trust hereof relating to Trust Funds so transferred.

**14. POWER AND FUNCTIONS OF THE OFFICE BEARERS:**

**i) CHAIRMAN:**

- a) The Chairman will be elected by the majority of the Trustees present in the meeting convened for that purpose.
- b) The Chairman will preside over the meetings of the Trust and conduct the proceedings.
- c) The Chairman in his discretion or by the request of one-third of existing members can call for a meeting of the Trustees.
- d) The Chairman is empowered to dissolve the Board or Other Bodies or Committees in any abnormal situation.

**ii) GENERAL SECRETARY:**

- a) The General Secretary of the Board of Trustees, elected under the control and supervision of the Board, shall conduct and manage all the affairs of the Trust, its properties and institutions, sign papers and carry on correspondence on behalf of the Trust and shall be responsible for the safe custody of records of the Trust, and keeping of proper accounts thereof.
- b) The management and affairs of the Trust shall vest in the General Secretary who will represent the Trust or its institutions or units before all authorities and exercise such power as is necessary or conducting the affairs of the Trust or its institutions or units in accordance with the decisions of the Board of Trustees.
- c) The General Secretary is empowered to decide on all matters arising in the administration of the Trust hereof including all questions relating to the interpretation of these presents, the administration of institutions or units maintained by the Trust or concerning any thing or any matter relating to or

concerned with or arising out of these presents or the operation thereof.

- d) The General Secretary is empowered to take decision on urgent matters but the Board should approve such decisions within a period of 30 days.
- e) The General Secretary is empowered to delegate by Power of Attorney or otherwise by way of resolution to any Trustees or any other persons such powers and authorities implied by law or conferred by statute of vested in the Trustees by these presents.
- f) He shall also perform such other duties as may be entrusted to him from time to time by the Board.
- g) The General Secretary shall attend to the correspondence and day to day affairs of the Trust.
- h) The General Secretary shall carry out all the resolutions adopted by the Trust and for that purpose he shall have the power to incur necessary expenditure from and out of the

funds of the Trust subject to be deemed fit by the situation incurred with sanction of the Board.

- i) He shall have the custody of the correspondence and other books relating to the affairs of the Trust.
- j) He shall be the Chief Executive Officer of the Board and ex-officio member of all sub-committees.

iii) **TREASURER:**

The Treasurer shall collect and receive all sorts of subscriptions, donations and deposit of money and grant receipts thereof. He shall keep or cause to be kept a true and correct account in proper books of all the money received or paid by him on behalf of the Trust.

15) **GENERAL MEMBER:**

The Board of Trustees may admit to membership, subject to such rules and regulations as the Trustees may prescribe any respectable person irrespective of religion, caste, creed or sex who

has attained the age of 21 (twenty one) years and agreed in writing to be bound by these presents and who in the opinion in the Board of Trustees will be interested in and contribute to the advancement of the "Aims & Objects" of the Trust. The power to admit members is the sole and absolute discretion of the Board of Trustees. The Board of Trustees may refuse to admit any person as member of the Trust without assigning any reason thereof.

**16) BOARD MEETINGS:**

- a) A meeting of the Board be held ordinarily at least once in 6 (six) months or earlier on the requisition of at least 1/3 of the Trustees to consider the affairs of the Trust and all the proceedings of the meeting shall be recorded in the minutes book to be preserved by the Secretary on behalf of the Trust. Notice of every meeting of the Board with the Agenda shall ordinarily be given by the Secretary or Convener to all the Trustees at least 7 (seven) clear days before the proposed date provided that in case of emergency there will be no time limit for serving the notice.

- b) The Chairman of the Board shall preside over the all meetings of the Board of Trustees. In absence of the Chairman of the Board the Vice-Chairman shall preside. In absence of the both, the Trustees present therein may elect a Chairman from among themselves to preside over the meeting.
- c) Every question which shall arise in every meeting of the Board shall be decided by the majority of the votes of the Trustees present and in case of equality of votes, the Chairman of the meeting shall have the second or casting vote, but in no other event shall any Trustees have more than one vote and there shall be no vote by Proxy.
- d) The proceedings of every meeting shall be entered in the minutes book maintained for the purpose and signed by the Trustees present at the meeting. The Chairman of the meeting and the General Secretary should sign at the end of the proceedings of the meeting.
- e) No proceeding of the meeting of the Board shall be invalid.

17. **Quorum:**

One-half shall be the quorum of any meeting.

**18. Receipts of Contributions:**

All the funds should be received only on account of or in the name of the Trust and receipts should be issued under the seal of the Trust and must be signed by the Secretary or the persons authorized by the Board by a resolution recorded in the minute's book. The Secretary shall be personally responsible for full and complete accounting for all the receipts and disbursements of the money and other properties received for the Trust. No money or property shall be received or used except for the purpose and objects of the Trust.

**19. Bank accounts and its operations:**

The Board of Trustee can open bank account in the name of the trust with any nationalized bank or other private/ foreign banks from time to time and can close the same if necessity arises.

The said bank account shall be operated jointly by the Treasurer along with any member of the board of the Trustee.

**20. Accounts and Audit:**

The Board of Trustees shall keep or cause to be kept true and correct account in proper books of all the monies and properties received and expended or disbursed or spent or invested for the objects and purposes of the Trust. Where found necessary separate account shall be kept for different departments or units of the Trust. The General Secretary shall prepare or cause to be prepared the statements of Accounts and the Balance Sheet and get the same audit and shall also prepare a detailed Annual Report for its distribution amongst the members. The official accounting year of the Trust shall commence from 1<sup>st</sup> April and end on 31<sup>st</sup> March of the following year or as decided by the Trustees from time to time in accordance with the prevailing laws.

**21. Inspection by Members:**

The Board shall from time to time determined as to what extent and at what times and places and under what conditions and regulations the books of account, the records or the properties of

the Trust or any of them shall be open for inspection to the members of the Trust.

**22. Immoveable Properties:**

All properties to be purchased or to be received as a gift or donation should be in the name of the trust and the Chairman or the General Secretary or the members authorized in this regard by the Board only can sign the Conveyance Deed, Agreement, etc. Any immoveable property belonging to the Trust shall be sold, exchanged, transferred, converted, mortgage or alienated only with the proper authority approved by the Board of Trustees by a resolution adopted in their meeting, in any manner whatsoever except when such sale, exchange, transfer, conversion, mortgage or alienation:

- a) Is imperative in the interest of the Trust and/or Institutions and
- b) Is not likely to adversely affect to any extent whatsoever the existence and benefit of the Trust, and

- c) Is decided to that effect by the Board in a meeting convened for this purpose by a resolution passed by at least 2/3<sup>rd</sup> majority of the Trustees present.

**23. Suits and Legal Proceedings:**

The Board or any one of the Trustees may apply for advice or the directions to the Court as occasion may rise. Power of Attorney may be granted to a particular person by a resolution of the Board in a meeting of the Trustees.

**24. Dissolution/ Cessation/ Winding of the Trust;**

The Trust is revocable Private discretionary Trust. The Trust may come to an end if for any inevitable reason the Trust fails or is dissolved or wound up or the Trustees unanimously decide to end the Trust then the property, funds and assets of the Trust that may remain after full satisfaction of the liabilities of the Trust will be transferred and handed over to any person or body of persons, AOP/AJP or firms or company or on such terms as the

Trustees may decide at a meeting to be convened for the said purpose and the decision of the Trustees shall be full and final and binding on all concerned. Upon distribution of the assets of the trust as aforesaid, the Trustees shall stand discharged of their duties as trustees. In this regard, following procedure must be followed:

- a) Notice of meeting for winding of the Trust is served on all the existing Trustees,
- b) Such meeting is attended by at least  $3/4^{\text{th}}$  of the existing Trustees,
- c) Decisions or resolutions in this regard is carried by the Boards of at least  $3/4^{\text{th}}$  of the Trustees present,
- d) At the time of meeting of the Board of Trustees, there shall exist all the minimum Trustees in office i.e. not less than 5 (five) Trustees and there should not be any vacancy existing on the minimum number of Board of Trustees.

25. **Amendments to the Scheme;**

If at any time it is found that alteration in any of the provisions of this Trust or Scheme for the purpose of effective achievements of the objects of this Trust are imperative and very essentials, then the Board shall approved such alteration by a resolution of at least 2/3<sup>rd</sup> member of the board passed in its meeting of the trustees and thereafter the modification shall become part and parcel of the terms, conditions and provisions of this Trust and this scheme.

The Board may at any time and from time to time make, amend, delete and rescind rules and bye-laws for the conduct of its business, for the control, management and administration of the Trust made under this Trust and for carrying out the objects of the Trust relating to any matter under this scheme, provided that such rules and bye-laws shall not be inconsistent with or repugnant to any of the provisions of the scheme of this trust. In other case the Indian Trust Act, 1882 should be followed.

**26. Declaration:**

This Trust and the scheme set forth under this indenture shall come into force immediately upon the execution and registration thereof.

The Trustees above named also hereby declare that they have consented to be the Trustees under this Trust accepted the Trust have taken delivery of the possession de jure and defect of the schedule fund of price of and that in witness whereof, they the Trustees above named as parties hereto, have affixed their signature hereunder.

**SCHEDULE**

At present there is a Corpus Fund of Rs.50,000/- (Rupees Fifty thousand) only in trust and there are no other movable or immovable properties at present in Trust .
