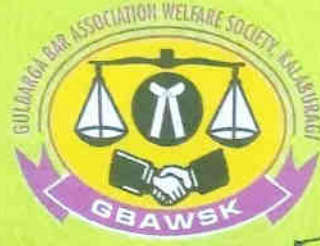


**AIMS AND OBJECTIVES :**

The aims and objectives of the trust shall be as under :-

- 1) To establish educational Institutions such as schools, colleges, institutions and to run the Educational Institutions, Colleges, Schools, Hospitals, Libraries, Nursing schools, Nursing training centre, Nursing colleges, provide medical, Technical, Arabic School, and all acts of charitable, Community Hall, Homeopathic & vocational and professional education and training institutions, Computer training and Educational course of all nature mentioned above and such as B.Ed College, M.Ed College, D.Ed College, Medical College and related courses and activities, centres etc. for students, men and women and do all acts necessary in the interest of Trust and open Hospitals and all types of Educational institutions etc. in all languages and give education to all caste, creed, sex, colour etc. and in the interest of women, children etc. and organize seminars, run institutions etc. and adult education etc
- 2) To establish hospitals, wards, rooms, clinics, offices, etc., in the name of the trust for the use of general public at large and help the patients who are sufferers from many or any kind of disease etc.
- 3) To arrange philosophical and spiritual courses, study circles, seminars, etc. by inviting the eminent speakers and scholars etc.
- 4) To establish and run residential and non residential educational institutions to impart formal education from the Pre-School (Nursery) level to post graduate level. This would include general school education, general degree and post graduate degree programs, vocational training, technical education programs, and professional degree programs.
- 5) To provide, establish, maintain, control and manage Colleges, Schools and other Educational Institutions, Charitable Institutions and to do all acts and things necessary for a conducive to the promotion of all types of Colleges, Schools and other Educational Institutions at Gulbarga Dist. and elsewhere.
- 6) To start establish, conduct, maintain and manage Reading Rooms, Libraries, Laboratories, Gymnasiums, Workshops, Publishing Houses Hostels, Residential Quarters, old-age homes and the like, for the aforesaid purpose.

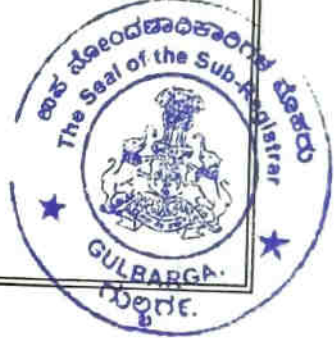

- 7) To establish promote, take over, associate with and run and educational institutions and other charitable institutions etc. and of education institution such as nursery, primary and high school and college in the medium of Kannada, English, or any other language.
- 8) To establish, construct and maintain auditorium/s function hall/s under the trust.
- 9) To give either for charges by the trust the auditorium, etc. of the Trust to be constructed, to others for conducting the functions like marriages etc. and other purposes.
  - a) To do any of such things or undertake any other activities as it may think fit by the trustees in the interest of the trust and for the benefit of the community at large and to improve the property owned and possessed by the trust.
  - b) The trust may acquire, establish, maintain accept the gifts of all cash and kind within the trustees and members of the trust and the persons who are willing to offer for the same and the property in the name of the trust and improve the trust and manage the affairs and also acquire by purchase, lease, gift, grant, legacy, bequeathal, exchange from any person etc.
  - c) To solicit, obtain or accept subscriptions, donations, grants, gifts, devises, bequests and trusts from any person, firm, Corporation, Institution or State & Central.
  - d) To acquire by gift, purchase, exchange, lease, on hire or otherwise howsoever any lands, buildings, easements, rights of common playgrounds, parks and any property, moveable and / or immovable and for any estate or interest for the furtherance of all or any of the objects of the trust.
  - e) To build, construct and maintain houses or other buildings and alter, extend, improve, repair, enlarge or modify the same including any existing buildings and to equip the same with light, water, drainage, furniture, fittings, instruments, apparatus and appliances and all other necessities for the use to which each building is to be put up or held.
  - f) To construct or otherwise acquire, layout, repair, extend, alter, enlarge, improve and use any land, recreation or pleasure-grounds, parks and / or any other immoveable property belonging to or held by the trust.
  - g) To accept and receive in any matter whatever any cash or immoveable or moveable property either unconditionally or subject to any special trusts created by any particular donor in furtherance of any one or more of the objects of the trust.
  - h) To make such steps by personal or written appeals exhibitions, public meetings, entertainments or otherwise as may from time to time be deemed expedient for the purpose of procuring contributions to the funds of the trust in the shape of donations, legacies, annual payments or otherwise.



- i) To print, publish and exhibit any books, pamphlets or posters that may be considered desirable for the promotion of the objects of the trust.
- j) To manage, transfer, exchange, mortgage, demise, dispose off or otherwise deal with any property whatever belonging to the trust with the permission of the trustees and the members of the trust in writing with quorum.
- k) To give loans, scholarships, freeships, prizes and monetary assistance to students of the trust's Institutions to help them in their studies.
- l) To pay of the funds belonging to the trust or out of any particular part of such funds all expenses of or incidental to the formation of the society and management and administration of any of the foregoing objects including all rents, rates, taxes, outgoings and the salaries of the employees.
- m) To invest and deal with any moneys of the trust not immediately required for any of its objects in such manner as may be from time to time determined.
- n) To draw, make, accept, endorse and discount Cheques, Notes or other negotiable instruments.
- o) For the purpose aforesaid, to sign, execute and deliver such assurances and deeds as may be necessary.
- p) To amalgamate with any other trust having same objects wholly or in part similar to the objects of the trust.
- q) To do all such other lawful acts, deeds or things as are incidental or conducive to the attainment of any of the above objects.

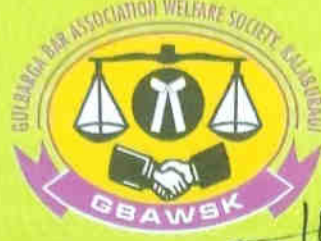
**Whereas,** apart from the aim and objects the trust also function the following :-

1. The trust is at perfect liberty to get avail and accept the donations of any kind from any of the Govt. Machinery and from private persons and from the N.R.I. or avail and accept the donations from other country also. The trust is entitled to get all benefits and also at at liberty to conduct the charity programme and collect the founds.
2. The funds of the trust shall be invested in the modus specified under the provisions of Sec. 13(1)(d) read with Sec. 11 (5) of the I.T. Act. 1961 as amended from time to time.
3. There shall be maintained all accounts of the Trust regularly. The accounts shall be duly audited by Chartered Accountant every year and the accounts shall be closed by 31st March.

4. No amendments to the Trust Deed / Memorandum of Association / Bye-laws/Rules regulation shall be made which may prove to be repugnant to the provisions of Sec. 2 (15), 11, 12 & 80G of the I.T. Act. 1961 as amended from time to time. Further no amendment shall be carried out without the prior approval of the commissioner of income tax.
5. In the event of dissolution or winding up of the Trust, the assets remaining as the date of dissolution shall under no circumstances be distributed among the trustees / members of the Managing committee but the same shall be transferred to another charitable trust whose objects are similar to those of these trust and which enjoy exemption under Sec. 80G of I.T. Act. 1961 as mentioned from time to time.
6. The trust formed shall be irrevocable.
7. The benefits of the trust shall be open to all irrespective of caste, creed or religion.
8. The funds and the income of the trust shall be solely utilized for the achievement of its objects and no portion of it shall be utilized for payment to the trustees/members by way of profit, interest, dividends.
9. Objects / Activities of religious in nature require deletion in case Recognition U/s. 80G of the Act is sought (by virtue of explanation 3 to Sec. 80G(5)).


**INVESTMENT :-** The funds of the trust shall be invested in the modes specified under provisions of Sec. 13(i) (d) read with Sec. 11(5) of the Income Tax Act 1961 as amended from time to time.

**BOARD OF TRUSTEES :**

1. There shall be 5 trustees including settlor/author (President) in the board of trustees, whose names are mentioned above. The said board of trustees shall be for life unless they resign or nominate from well wishers and like minded people and they shall be given membership as the trustee in their place, with the consent of the author/founder chief trustee the decision of the quorum will be final.
2. The board of trustees shall constitute a President, Secretary & Members among the above trustees and member.
3. The trustees of the Trust are at liberty to co-opt the members of the Trust and form the adhoc committee of the Trust and appoint the members of the Trust and delegate powers to them to do the work in the best interest of the Trust. They can form the committees and sub committees and delegate powers for the smooth functioning of the trust property.
4. In case of vacancy caused by death, resignation, renunciation, expulsion or otherwise the remaining trustees shall fill up the vacancy so arising by co-opting any other suitable person as an member committee within a period of six months.

**SECRETARY :**

1. He shall convey meeting of the board of trustees and to maintain regular records of proceedings of the meeting.
2. That he shall be the custodian of all the correspondence and records of the trust and carry out other responsibilities entrusted to him from time to time by the board of trustees.
3. He shall have the power to utilize the funds required for any work of the Trust upto the limit of the Rs. 10,000/-.
4. The Secretary shall look after all the legal matters in respect of the trust and property of the trust.
5. He shall keep all the records upto date pertaining to the money transaction.
6. If any conflict or complications arises or any matter among the trustee, the decision of the majority of the board of trustee will prevail and final.

**AMENDMENTS TO THE DEED OR TRUST :**

The Board of trustees by its resolution by 2/3rd majority of the total member of the trust shall have the power to change, amend, modify or alter and in the deed of trust, its term and clauses for smooth running of a trust in accordance with law from for time to time but such changes or alterations and amendments shall not alter in any way the nature and character of the trust.

**FINANCIAL YEAR :**


