the objects set out in this trust deed and for fulfillment of which, the terms and conditions are more particularly set out hereunder.

AND WHEREAS THE TRUSTEES named above have agreed to accept the office of the Trustees for the purpose of carrying out the wishes of the SETTLOR of the Trust under the provisions and directions set forth herein, so as to enable to pursue its vowed objects.

NOW THIS DEED WITNESSETH AS FOLLOWS:

1. NAME :

The name of the Trust shall continue to be "PRAGYA UNIVERSAL FOUNDATION" hereinafter referred to as TRUST only for the sake of briefing. The Trust will function as a non-communal and a secular organization.

2. REGISTERED OFFICE :

The principal office of the Trust shall be situated at NICHALI KILA, GARHPAR, BIHARSHARIF (NALANDA) BIHAR – 803101 or such other place as the Trustees may from time to time decide. The Trust may also carry on its work at any other place or places as decided by the Trustees.

3. INTENT :

The Core intention of the TRUST shall be to work for the universal peace, prosperity, equality and justice of the Global and local society at large.

4. NATURE OF THE TRUST :

The TRUST shall be a charitable Trust in nature and no part of the Corpus Fund, under any circumstances, whatsoever be paid or lent or revert to Settlor or Trustee/s, their heirs, nominee/s, descendent/s, legal representative/s, assignee/s save for furthering the objectives of the TRUST.

5. AIMS AND OBJECTS:

The aims and objects for which this Trust is being formed are:-

EDUCATIONAL

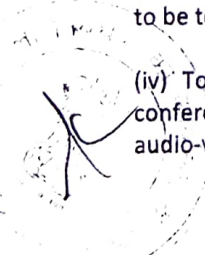
(i) Advancement and propagation of education and learning including establishment, maintenance and support of educational institutions.

(ii) To establish, maintain, take over the management, administer or run any institutions, establishments engaged in the imparting of education to students up to any level that may be found necessary and / or desirable.

(iii) To establish, run, manage, and administer any educational institution to train/educate persons to be teachers/technocrats.

(iv) To hold, arrange and organize meetings, lectures, talks, discussions, seminars, symposia, conferences, competitions, research and study visits, tours, excursions, exhibitions, debates, cinema, audio-visual program, the artistic performances and to the cultural activities, sports and games.

(v) Establishment, maintenance and support of libraries, museums and reading room, distribution of books and Hostel facilities etc, for advancement of education and knowledge in general.

HEALTH

(vi) Establishing, running & promoting HOSPITALS, CLINICS, DISPENSARIES, HEALTH CENTRES, FAMILY PLANNING CENTERS, NASHA MUKTI KENDRA, MATERNITY HOMES, with the financial assistance of the people & Government for the welfare of the general mass (Specially in the remote ruler and slam area).

(vii) Organizing HEALTH AWARENESS CAMP to educate the masses about the evils & adverse effects of the HAZARDOUS DISEASES like CANCER, AIDS etc. and to provide them with the FREE guidance & medical help for Medicare & Welfare of the general masses.

(viii) To combat the growing menace of alcoholism and drug addiction by creating awareness towards ill effects of alcoholism and drug abuses, to make efforts for prevention of drug abuses and treatment & rehabilitation of drug addicts free of cost.

(ix) To promote, propagate and implement the scheme of traditional system of medicine such as Unani, Ayurveda, Naturopathy, siddha and Homeopathy etc. and make arrangement of proper educations and trainings In this field free of cost.

(x) To organise symposium, seminars, conferences, exhibitions, study groups, workshops and to arrange printing and publishing of books, folders, posters, periodicals, journals, thesis papers, other literatures of topical and long range significance and to conduct study and research in the field of Health & Medical Science.

(xi) To conduct research work in field of health and medicine for advancement of medical science.

xii To receive and collect grants, donations, gifts, fees or subscriptions etc. either in cash or in kind from national/international agencies as permissible under the law (movable or immovable) and manage & administer the funds at the disposal of the objects of the "PRAGYA UNIVERSAL FOUNDATION".

xiii. To acquire, by purchase, take on lease, hire by gift or otherwise receive and hold properties, both movable and immovable including securities and negotiable instruments.

xiv. To purchase construct, manage and alter buildings and equip them suitable for the purpose of "PRAGYA UNIVERSAL FOUNDATION".

xv. To manage, sell, transfer, pledge or otherwise dispose of or deal with property of any kind, which may be at the disposal of the "PRAGYA UNIVERSAL FOUNDATION".

xvi. To enter into contracts on and in behalf of the "PRAGYA UNIVERSAL FOUNDATION".

xvii. The advancement of any other objects of general public utility for achieving any or all the above objects the trust shall raise funds through donations, grants and contribution and also obtain and

9. **RULES AND REGULATIONS :-**

- i) The objective and purposes of the foundation/ trust shall be as mentioned in para 5.
- ii) Definitions :

In these Rules :-

- a) Board of Trustees/ Governing Body means the Board which under the rules is constituted to be the Board of Trustees/ Governing Body of the Foundation.
- b) Foundation and/or Trust mean the PRAGYA UNIVERSAL FOUNDATION.
- c) Managing Trustee means the founder Chairman/ Seller of the foundation.
- d) Year means the financial year from 1st April to 31st march (but the first year shall be deemed to have commenced from the date of Registration and ended on 31st March).
- e) Act means the Indian Trust Act, 1882.
- f) Office bearers mean Board of Trustees and/or Posts created by the Board of Trustees for the administration purposes.
- g) The founder members mean the settlor of one part the Trustees of the other part.

10. **BOARD OF TRUSTEES :-**

- a) The Board of Trustees will ordinarily consist of not less than three and not more than ten members. The founder and settlor of the Trust and other founder trustees shall hold office for life. Five members agreed upon by the Trustees above named and the co-opted trustees will form the Board of Trustees.
- b) The Trustees for time being at their discretion may co-opt persons to the Board of Trustees from the Governmental or non-governmental organizations, individuals of national/ international repute.

c) The trustees nominated shall hold office for three years and/or liable for retirement. The Trustees whose term of office expires after the period of three years are eligible to be co-opted as trustee again by the existing Trustees. The trustee may if so desires resign his Trusteeship.

d) The Chairman of the Trust Board will have the right to cast extra vote in case of dispute.

e) The founder/ settlor of the Trust shall be the managing Trustee for life and after him the Managing Trustee will be elected for (3) Three years terms with two-third majority. The Managing Trustee shall act as chairman and preside at all the meetings of the Trust.

f) The Trustees may from time to time engage any person as trustee it is absolute discretion of the Trustees, but in no case the number of Trustees at any time shall – exceed ten as fixed aforesaid.

g) The trustees may appoint various expert committees and regular office bearers to discharge the set aims and objectives at places of convenience.

11. POWER AND DUTIES :-

The general management and control of the foundation for the purpose of managing the foundation affairs and properties (which may include any business undertaking) and carrying out the object of the foundation aforesaid shall be vested in the Trustees and without prejudice to the generality of the objects and powers mentioned herein for the purpose of attaining and/or carrying on all or any of the objects specified in clause (5) above in chapter Aims & objects the Trustees shall have power to accept any voluntary donations contributions, grant or subscription in cash or kind from the settlor the members of his family or any other persons or concern what so ever on such terms and conditions as the Trustees may in their absolute discretion think fit and proper.

12. DISSOLUTION

In the event of dissolution of the Trust which may be decided by unanimous resolution of Trustees, the funds held with the Trust on that date, will be donated to any other Trust or institution having similar objects as that of the Trust as determined by the Board of Trustees. However, no part of the funds of the Trust will, directly or indirectly, be given to either of the Trustees or their relations.

All the powers and provisions hereof shall be construed as being subject to the restrictions and imitations herein contained.


