TRUST DEED OF SR FOUNDATION

This Deed of Trust is made and executed at Ariyalur, Tamil Nadu, India, on this 09th day of April, 2025.

1. AUTHOR OF THE TRUST

Mr. Rajendran, residing at 3, Sambasivam Pillai Street, Ariyalur - 621704, hereinafter referred to as the "Author of the Trust", is desirous of creating a public charitable trust for the purposes and objectives set forth herein and has set apart an initial sum for the same.

2. TRUSTEES

The following individuals are appointed as the **Trustees** of the Trust and shall hold office for their lifetime, or until they resign, or otherwise become incapable of holding office:

- i. Mr. Pravin Kumar
- ii. Mrs. Selva Priya

(Both residing at 3, Sambasivam Pillai Street, Ariyalur - 621704, hereinafter collectively referred to as the "Trustees")

3. NAME OF THE TRUST

The name of the Trust shall be **SR Foundation, Ariyalur**, (hereinafter referred to as the "Trust").

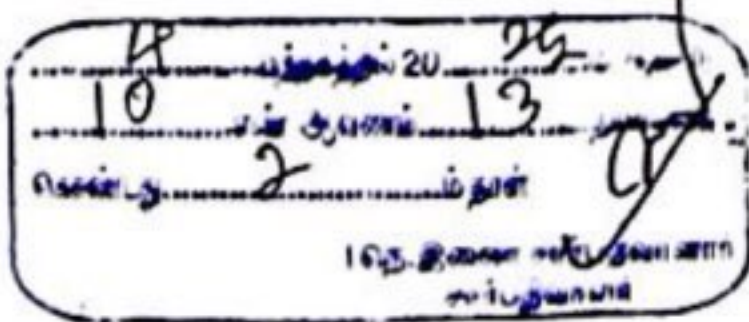
4. REGISTERED OFFICE

The Registered Office of the Trust shall be situated at **3, Sambasivam Pillai Street, Ariyalur, Tamil Nadu, India**. The Trustees may, by resolution, change the registered office or establish branch offices at any place in India for effective administration of the Trust.

5. OBJECTIVES OF THE TRUST

The Trust is established for charitable purposes within the meaning of Section 2(15) of the Income Tax Act, 1961, and its objectives include but are not limited to:

- i. To establish, run, maintain, and support educational institutions, including schools, colleges, research centers, and coaching centers.
- ii. To provide scholarships, financial aid, books, and educational materials to meritorious and underprivileged students.
- iii. To undertake charitable activities such as free distribution of food, clothing, and medical assistance to the needy.

6. BENEFICIARY CLAUSE

The trust is established with a purely charitable objective, devoid of any commercial intent, to serve the general public without discrimination based on caste, creed, gender, or religion. The Trust shall act in alignment with the constitutional values of equality and non-discrimination.

7. INITIAL CORPUS OF THE TRUST

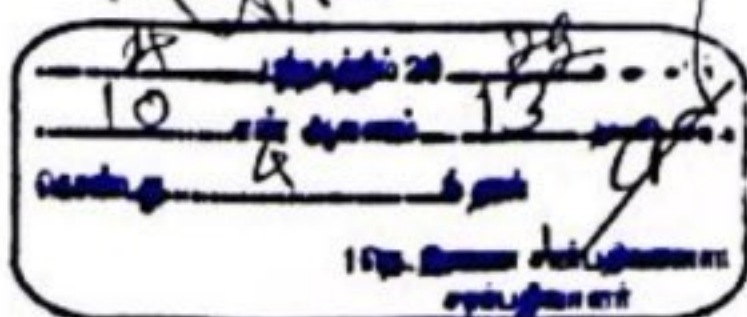
The Author has contributed an irrevocable sum of Rs. 10,000/- (Ten thousand Rupees only) towards the initial corpus of the Trust. The Trust may receive further donations, grants, and contributions from lawful sources within India or abroad (subject to FCRA compliance if applicable).

8. GOVERNANCE AND ADMINISTRATION

- i. The Trust shall be governed and administered by the Board of Trustees.
- ii. Mr. Pravin Kumar and Mrs. Selva Priya shall serve as **Managing Trustees** for their lifetime, and shall be responsible for the day-to-day administration of the Trust.
- iii. The Board shall meet at least once every six months.
- iv. Resolutions shall be passed by majority of Trustees present and voting; in case of a tie, Managing Trustees shall have a casting vote.
- v. Minutes of every meeting and resolutions shall be recorded and maintained in the minutes register.
- vi. The Board shall maintain proper books of accounts, records of financial transactions, and documentation of charitable activities.
- vii. The Trustees shall have authority to appoint employees, volunteers, consultants, and advisors as necessary for carrying out the Trust's objectives.

9. ADDITION, RESIGNATION, OR REMOVAL OF TRUSTEES

- i. New Trustees may be inducted by a resolution passed by not less than two-thirds of the existing Trustees.

- ii. A Trustee may resign by giving written notice of 30 days.
- iii. Trustees may be removed for misconduct, incapacity, or dereliction of duty by a majority of remaining Trustees.
- iv. The appointment or removal of Trustees shall be recorded in the minutes of meetings.

10. BANK ACCOUNT AND FINANCIAL MANAGEMENT

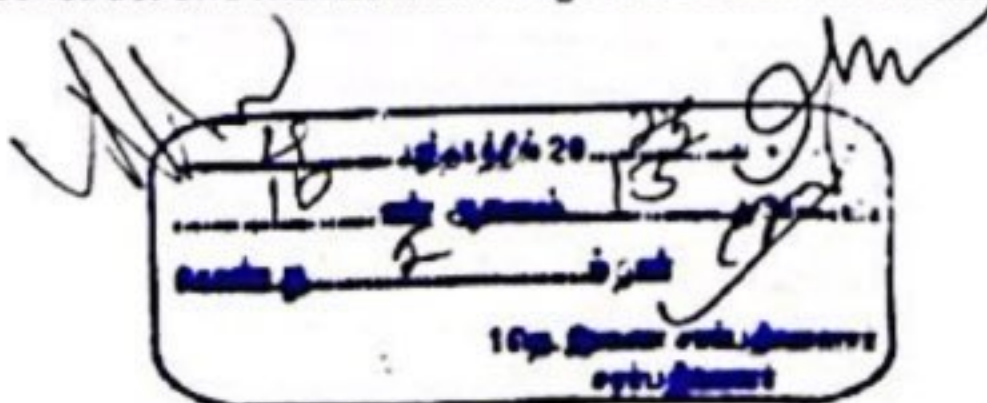
- i. The Trust shall maintain one or more bank accounts in its name with any scheduled/nationalized bank.
- ii. The bank accounts shall be operated by either of the Managing Trustees, jointly or individually, as resolved by the Board.
- iii. Proper records of income, expenditure, and donations shall be maintained.
- iv. The accounts of the Trust shall be audited annually by a Chartered Accountant.
- v. The funds and income of the Trust shall be used for achieving all objectives.
- vi. No income or asset of the Trust shall be distributed to any Trustee or person for private benefit.

11. COMPLIANCE WITH THE INCOME TAX ACT, 1961

- i. The Trust shall apply for registration under Section 12A of the Income Tax Act, 1961.
- ii. The Trust shall apply for approval under Section 80G of the Income Tax Act, 1961, so that donors may avail tax deductions.
- iii. The Trust shall maintain proper accounts and records and shall get its accounts audited annually.
- iv. The Trust shall apply for registration under the Foreign Contribution (Regulation) Act (FCRA) if it intends to receive foreign contributions.

12. POWERS OF THE TRUSTEES

- i. To acquire, purchase, lease, or rent movable and immovable properties for the objectives of the Trust.
- ii. To construct and maintain buildings and other infrastructure for Trust-related purposes.



- iii. To accept donations, grants, and financial assistance from individuals, institutions, and government bodies.
- iv. To enter into agreements or collaborations with other organizations for implementing Trust objectives.
- v. To invest Trust funds in modes permitted under **Section 11(5)** of the Income Tax Act, 1961.
- vi. To frame rules, guidelines, and bylaws for efficient administration of the Trust.
- vii. To sell or dispose of Trust properties, with proper justification and compliance, provided the proceeds are solely applied to charitable purposes.

13. AMENDMENT TO THE TRUST DEED

- i. No amendment shall be made that alters the charitable character of the Trust.
- ii. Any amendment shall require unanimous consent of all serving Trustees and shall be subject to compliance with applicable laws.
- iii. Any amendment affecting tax exemptions shall be subject to approval by appropriate authorities (such as the Income Tax Department or FCRA authorities).

14. DISSOLUTION CLAUSE

- i. The Trust shall be irrevocable.
- ii. Upon dissolution or winding up, all assets shall be transferred to another Trust or institution registered under **Section 12A** and recognized under **Section 80G**, having similar objectives.
- iii. Under no circumstances shall the assets or income of the Trust be distributed among the Trustees or used for private benefit.

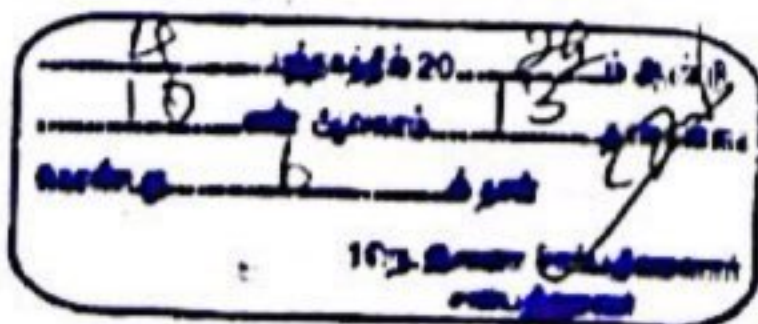
15. INDEMNITY CLAUSE

	g. No such activity shall be carried on by the trust or institution which is not in accordance with all or any of the conditions subject to which it was registered.
	h. The trust or institution shall comply with the requirement of any other law, as referred to in item (B) of sub-clause (i) of clause (b) of sub-section (1) of section 12AB.
	i. The form for registration in Form No 10A has been duly filled in by providing all the information or documents and no false or incorrect information or documents have been provided.
	j. The trust or institution shall apply for registration within 6 months of commencement of the activities or at least 6 months prior to the expiry of period of provisional registration, whichever is earlier.
	k. Where the trust or institution has adopted or undertaken modifications of the objects which do not conform to the conditions of registration, the trust or institution shall make an application in the prescribed form and manner to the Principal Commissioner or Commissioner, for registration of the trust or institution, within a period of thirty days from the date of the said adoption or modification.
